2. The **PENRO, Surigao del Norte**, now invites bids for the above Procurement Project. Completion of the Works is required **Rehabilitation of DENR PENRO SDN Main Building Phase I – 150 Calendar Days**. Bidders should have completed a contract similar to the Project. 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on **November 24, 2022 to December 1, 2022** from given address and website/s below **Upon payment of the Bidding Documents for the procurement the Bidding Documents amounting to Php10,000.00 the said amount shall be paid at the office of PENRO-Surigao del Norte, Brgy. San Juan, Surigao City and look for Maria Salome C. Zapater, Collecting Officer.**

The Procuring Entity shall allow the bidder to present its proof of payment for the fees and **Special Power of Attorney (SPA) for representative during Bid Opening/Evaluation.**
