1. The **PENRO-Surigao del Norte**, through the intends to apply the sum of **Php2,100,000.00** being the ABC to payments under the contract for **Procurement of Motor Vehicle (4x4 Pick Up) of PENRO-Surigao del Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Select this for Framework Agreement:

- PENRO-Surigao del Norte**, using a **Single-Year** for a duration of **Thirty (30) Calendar Days**. Framework Agreement, intends to apply the sum of **Php2,100,000.00** the ABC corresponding to the total cost of the item to be bid out, **One (1) unit as to quantity** being the ABC to payments under the contract for each item. Bids received in excess of the total cost per item shall be automatically rejected.
2. **PENRO-Surigao del Norte**, now invites bids for the above Procurement Project. Bidders should have completed, within **December 5, 2022** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
 4. Prospective Bidders may obtain further information from **PENRO-Surigao del Norte/Chirry Lyn B. Arayan-Supply Officer/Procurement Officer** and inspect the Bidding Documents at the address given below during **8:00 a.m. to 5:00 p.m.**
 4. A complete set of Bidding Documents may be acquired by interested Bidders on **November 14, 2022 to November 21, 2022** from the given address and website(s) below **Upon payment of the Bidding Documents in the amount of Php5,000.00, the**

said amount shall be paid at the office of PENRO, Surigao del Norte, Brgy. San Juan, Surigao City and look for Maria Salome C. Zapater, Collecting Officer.

5. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and **Special Power of Attorney (SPA)** for representative during Pre-bid Conference.
6. **PENRO-Surigao del Norte** will hold a Pre-Bid Conference¹ on **November 23, 2022 at exactly 9:00 a.m.** at **PENRO-Surigao del Norte Conference Room located at Brgy. San Juan, Surigao City**, which shall be open to prospective bidders.
7. Bids must be duly received and stamped by the BAC Secretariat through manual submission at the office of **PENRO-Surigao del Norte, Brgy. San Juan, Surigao City** on or before **December 5, 2022** at exactly **4:00 p.m.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 6, 2022** at exactly **9:00 a.m.** at the **PENRO-Surigao del Norte Conference Room located at Brgy. San Juan, Surigao City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. **PENRO-Surigao del Norte** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
